ENTRY DEADLINE : February 1, 2020

The Curating committee will meet once a month in order to review applications. While some exhibitor spaces will be reserved up until 1 February 2020, **those who apply early may have a better chance of being selected.**

The file (digital only) must include the completed registration form and two photos of your work. Once we have validated your application, we will get back to you as soon as possible.

Drawing, ink, watercolor, collage, engraving, photo, painting, mixed media.

Each Artist is invited to present from 1 to 4 works. The selling price of each work is freely determined by the Artist. 0% commission on sales. The sales of the works are made directly in the name of the Artist.

- Right to hang: **40 €** per painting
- Transport costs (optional): **45 €** per work transported.
- 1/3 of page in the catalog (required): **50 €**

GOOD TO KNOW...

You are invited to pay within one month after validation of your project. After this period your registration will be null and void.

The works must imperatively bear labels indicating: the name of the exhibitor, his postal address, his telephone number, the nature and the title of the work and its selling price in Euros.

The Show Curating Committee alone determines the placement of your works. In case of dispute, no refund will be made.

The organizers decline all responsibility in case of loss, damage during transport, assembly, disassembly and, similarly, with regard to theft or destruction of the works entrusted to it. Participants are free to sign up for personal insurance against all these risks if they wish. No complaint will be admitted.
